3. In terms of the Port Rules - "**vessel agent**" refers to the *agent* of the owner of the vessel.
4. "**owner**" means any person to whom a vessel or pleasure vessel or a share in a vessel or pleasure vessel belongs or any other organisation or person, such as the manager or charterer, who has assumed the responsibility for the operation of the vessel or pleasure vessel from the owner of the vessel or pleasure vessel.

5. "**vessel**" means any water-navigable vessel or structure and includes a *passenger vessel*, ship, seaplane, s. non-displacement vessel, but excludes a *pleasure vessel*, to which Part B of Chapter 2 applies.
6. **small vessel** means a commercial small *vessel* that:
- is registered in the *Republic*;
 - lies in, is used in or operates from a *port*; and
 - includes a tug, *fishing vessel*, launch, barge, lighter, rowing boat, skiboat, sailing boat, yacht or similar vessel, or a hulk of any of the vessels enumerated, but excludes a *pleasure vessel*.
